It may be used to conduct a self-audit to check for compliance with pesticide regulations. The list is NOT all-inclusive of all pesticide regulations that may impact your firm. License Information: Act 451, Part 83, Section 8313

Element Present? Yes or No	Required Element For Licensing
	Requires a pesticide applicator business license for commercial applicators who hold themselves out to the public as being in the business of applying pesticide; MCL 324.8313(1).

Applicator Information: Act 451, Part 83, Section 8312 & 8314

Element Present? Yes or No	Required Elements For Pesticide Applicator Credentials	
Requires a pe apply a pestici	Requires a person to be either a certified or registered applicator if they apply a pesticide for a commercial purpose or in the course of their employment; MCL 324.8314(1).	
	A person shall only make pesticide application in the category for which he or she is certified or registered; MCL 324.8314(5).	
	A person shall display his or her certificate upon the request of an authorized MDARD official, MCL 324.8312(9), OR, a person shall display his or her registration certificate upon the request of an authorized MDARD official, MCL324.8314(9).

	Requires a the name of the licensed application firm and at least one of the following: - Firm address - Phone number - USDOT Census Number Information must be in typeface 3" in size or larger, R285.637.4(I).

Personal Protective Equipment (PPE), Regulation 637, Rule 9

Element Present? Yes or No	Required Elements For PPE
	Requires applicator to follow label directions regarding PPE, R285,637(1).
	Long Pants. Requires commercial applicator to wear certain minimum PPE, unless otherwise directed by the pesticide label, including long pants, R285.637.9(2)(a).
	<u>Protective Footwear</u> . Requires commercial applicator to wear certain minimum PPE, unless otherwise directed by the pesticide label, including protective footwear, R285.637.9(2)(b).
	Long-sleeved shirt. Requires commercial applicator to wear certain minimum PPE, unless otherwise directed by the pesticide label, including protective long-sleeved clothing. Short-sleeve clothing may be worn if water and soap or other protection is in place that provides comparable or greater protection and is immediately available and short-sleeve clothing is not prohibited by the pesticide label, R285.637.9(2)(c).
	<u>Protective gloves</u> . Gloves that are impervious to the pesticide in use shall be worn in any situation where the individual's hands are likely to come into contact with a pesticide, unless other protection is in place that provides comparable or greater protection, R285.637.9(2)(d).

Drift Management & Off-Target Direct Discharge, Regulation 637, Rule 4 & 10

Element Present? Yes or No	Required Elements For Drift Management.
	Pesticide applications shall be made in a manner that minimizes off- target drift, unless prior authorization and consent is obtained from the owner or resident of the land onto which drift may occur, R285.637.10(1).
	When pesticide off-target drift is likely to occur due to the nature of the application or atmospheric conditions, including, but not limited to wind speed and direction, a drift management plan shall be utilized, R 285.637.10(3). Drift management plans shall be in writing R285.637.10(4).
	Pesticide applications shall be made in a manner that prevents off-target direct discharges of pesticides, R285.637.4(b).
	Applications shall not occur when weather conditions favor the off- target drift of pesticides or prevent the proper deposition of pesticides to the target area, R285.637.4(i).
	Before applying a pesticide, the applicator shall identify any sensitive areas that are located on properties adjacent to the target area and shall use appropriate precautionary measures to prevent the direct discharge or drift of pesticides to those areas, R285.637.4(j).

Spill Response, Regulation 637 Rule 4 & 8

Element Present? Yes or No	Required Elements For Spill Response	
	Any person who mixes, load, or otherwise uses pesticides shall have immediate access to a spill kit, R285.637.4(m). Note: "Spill kit" is defined by R285.637.2(k) to mean a portable kit or other equipment that is designed to recover, minimize, contain, or absorb spills, leaks, releases, or other discharges of pesticides	
	Spills, leaks, releases, or other accidental discharges of pesticides or pesticide-containing materials shall be promptly contained and recovered in a manner that assures the protection of human health and the environment, R285.637.8(5)	

Pesticide Label Information

Element Present? Yes or No	Required Element For Pesticide Label
	Each person shall follow recommended and accepted good practices in the use of pesticides, including, but not limited to, use of a pesticide in a manner consistent with its labeling, MCL 324.8311(9). Also, a pesticide shall be used in a manner that is consistent with its label, R285.637.4(a).

	Requires a the name of the licensed application firm and at least one of the following: - Firm address - Phone number - USDOT Census Number All lettering must be in typeface that is 3" in size or larger, R285.637.4(I).

Element Present? Yes or No	Required Element For Equipment	
	When making a broadcast, foliar or space application of pesticides to an ornamental or turf site, other than a golf course or farm production area, a commercial applicator shall post a lawn marker (size and contents are specified by rule) at the primary point or points of entry, R285.637.11(2).	
	When making a broadcast, foliar or space application of pesticides to public or private golf courses the applicator shall notify the users of, or visitors to, the golf course about certain pesticide issues (identified by rule) by prominently displaying a poster in the pro shop and/or locker rooms, and/or registration area, R285.637.11(3)(a).	
	When making a broadcast, foliar, or space application to a public or private golf course, the applicator shall post in a conspicuous area on the 1 st and 10 th tees a sign that includes specific information (specified by rule) about the pesticide treatment, R285.637.1(3)(b).

	Concentration of pesticide applied; 15 (2)(b) Note: must be recorded showing amount of formulated material plus amount of carrier used to make an end use dilution example: 2 fl oz per 5 gal H2O, premixed or granular may be shown as "ready-to-use" or RTU or other similar designation.
	Amount of pesticide end use dilution; 15 (2)(c) example: 48 gal (product + carrier)
	The target pest, purpose, or crop site; 15(2)(d)
	The date the pesticide was applied; 15(2)(e)
	The address or location of the pesticide application;15(2)(f)
	The method of application; 15(2)(g) example: spreader, duster, etc.
	The rate of application; 15(2)(g) example: 6 lbs per 5000 sq ft, to run-off
	Records maintained at least 1 year following application of general use product; 15(2)
	Records maintained at least 3 years following application of restricted use product; 15(1)

Applicator Service Agreement (Customer Receipt Requirements): Regulation 637 Rule 12

Element Present? Yes or No	Service Agreement
	Before applying a pesticide, a commercial applicator who is required to be licensed by the Act, or his/her authorized representative, shall enter into an oral or written service agreement with the customer or authorized agent. The agreement shall specify the customer consent to services; the name, address and phone number of firm providing the pesticide application service; the approximate schedule, frequency and duration of the anticipated services, R285.637.12(1)

	A general description of the target pest(s); Rule 12(2)(c)
	Common name of active ingredient; Rule 12(2)(d)

	Precautionary warnings which are pertinent; 12(2)(f)
	Information provided (a) not later than at the time of each pesticide application OR (b) electronically within 48 hours with written approval prior to application; Rule 12(3)
